# 7. <u>Travel Information</u>

7.1 <u>Travel information</u>

The organiser will provide the shuttle from the airports of Saarbrücken, Luxembourg, Cologne, Stuttgart, Frankfurt/Main and Frankfurt/Hahn as well as the railway station of Saarbrücken according to the travelling details of the delegations. Teams arriving by their own car/bus are requested to go directly to the hotel.

#### 7.2 <u>Shuttle service</u>

The organiser will provide shuttle services during this EPC.

# 8. Safety Requirements

The host has to make sure that all safety requirements are met according to the rules of the respective sport discipline.

The host has to ensure that a medical first aid responder will be present at the competitions.

The host is responsible for a safety and security analysis of the risks during this EPC to determine the necessary precautions and measures.

#### 9. <u>Insurance</u>

Everyone involved in the USPE EPC Volleyball Women is responsible for his/her own insurance cover. The participating member countries are responsible for and undertake to conclude all necessary and adequate insurance cover (e.g. accident and health insurance) for their whole delegation members at their own expense for the whole duration of this EPC. Claims for damages against the USPE are expressly excluded.



# 10. Competition Rules

The Final Round will be played in a Group Stage considered of two groups with four teams where each team will play against the other in its group. After the group stage, the first two teams of each group will play crossover in the Semi-Finals for the Bronze Final and Final. Teams placed in groups as third and fourth will play in matches for their final placement.

Classification during the Group Stage

1. Match points

Match won	(3-0 or 3-1)	3 points
Match won	(3-2)	2 points
Match lost	(2-3)	1 point
Match lost	(0-3 or 1-3)	0 points

- 2. Set quotient
- 3. Set points quotient
- 4. The winner of the match opposing the two concerned teams is classified above the looser.

There is a tie between participants when each participant has the same number of matches won. In case of a tie, the standing of the participants is established by using the following criteria in the following mentioned order, until the tie ends:

- a. In descending order by the number of allocated points for won and lost matches,
- b. In descending order by the set quotient resulting from the division of all sets won by all sets lost during the Final Round,
- c. In descending order by the set points quotient resulting from the division of all set points scored by all sets points lost during the Final Round,
- d. In descending order by the result(s) of the match(es) played between them.


#### 11. <u>Event</u>

#### 11.1 Draw and mode of the Final Round

Germany, as organiser, is seeded as A1 and the Czech Republic, as 2<sup>nd</sup>-placed at the last USPE EPC Volleyball Women 2019, is seeded as B1.

The six remaining qualified member countries – Belgium, Finland, Greece, Italy, the Netherlands and Norway – were drawn by lot for the respective positions (A2-A4, B2-B4).

The draw for the Group Stage of the Final Round took place during the 16<sup>th</sup> USPE EPC Judo on 15<sup>th</sup> June 2024 in Sofia/ Bulgaria with the attendance of USPE officials and representatives of the USPE member countries with the following result:



#### 11.2 Competition area

The Matches will be played at Sportcampus Saar Hermann-Neuberger-Sportschule 4, 66123 Saarbrücken Multifunktionshalle 8 <u>https://sportcampus-saar.de/anfahrt-parken/</u>, which is located nearby the hotel (car distance of about 20 minutes depending on the traffic).

#### 11.3 Participants

According to item 4.4.2 of the USPE Competiton Rules in the Final Round each member union shall be allowed to enter up to 14 players as well as up to four attendants. The list of the players is closed during the accreditation. No changes will be allowed after.

#### 11.4 <u>Team Sport equipment</u>

The official ball for the Final Round will be "MIKASA V200W".

Teams must have a minimum of 2 sets of shirts and:

- All teams shall wear uniform sportswear displaying the emblems of their individual member union.
- Each team will have to envisage 2 sets of shirts of various colours. During the control, the team leader of delegations will have to indicate their set A and B of the shirts. The teams "home" (named first) will play with the set A of the shirts, the teams "guest" (named second) will play with a various colour of the shirts.

In the event of similar colours at the time of a match, the named team second must change their shirt.

• The jerseys of the players must have numbers on the front and on the back according to the international rules. Numbers on the shorts are not mandatory.

Every player has to play with the same number during the whole Final Round of the  $5^{th}$  USPE EPC Volleyball Women 2024.

#### 11.5 Official Training

Official training will be arranged on the arrival day with approx. 45 – 60 minutes for each team in the competition hall depending on the arrival.

#### 11.6 Laundry/Gym/Additional Services

The organiser provides a fitness studio during the stay. It is located in the police area on Mainzer Straße in Saarbrücken. A shuttle service will be arranged.

#### 11.7 Decorations and honours

The winner of the Final Round of the 5<sup>th</sup> USPE EPC Volleyball Women 2024 is "European Police Champion".

• <u>Medals:</u>

Teams taking the first, second and third place are awarded with medals.

 <u>Other awards:</u> The organiser will award special prizes to: best spiker, best block, best libero and best player overall.

#### 12. <u>Referees</u>

The provisions of the USPE Competition Rules, item 2.4, shall apply.

The organiser is in charge of ensuring that there are a sufficienty number of referees. The minimum standard for the referees is the highest national level.

Exceptions to this must be approved by the competent member of the Technical Commission in charge for the respective sport and the USPE Secretary General.

According to item 2.4.2 of the USPE Competition Rules, in Volleyball each country qualified for the Final Round must provide a referee.

In case of non-compliance, the respective country has to pay an additional fee to the USPE. This fee will be transferred to the organiser to pay for a substitute referee. The amount of the fee (500,00  $\in$ ) is fixed by the USPE Executive Committee.

#### 14. Jury of Appeal

The provisions of the USPE Rules and Regulations, Article R 19, shall apply.

The appeal jury is installed at each European Police Championship. It is responsible for all appeals concerning the organisation and the regular course of events of the championship in question. It is comprised of:

- 1. USPE Secretary General Andreas Röhner or his appointed deputy as chairperson,
- 2. USPE Technical Delegate for Volleyball, Mr. Dirk Weninger,
- 3. Polizeihauptkommissar, René Dewes, Tournament Director
- 4. Ralph Barnstorf, Head Referee

All appeals have to be made in writing by the delegate or one of the attendants of the member union in question within less than an hour after the end of the fixing or the publication of the results unless the respective international sport rules specify different.

The delegate or one of the attendants of the member union has to enclose an appeal fee with the appeal in order for the appeal to be valid. The deposited sum will be refunded to its owner if the appeal proves to be justified. If the appeal is rejected the sum deposited is retained by the USPE.

#### 15. Eligibility to start

The provisions of the Statutes, the Rules and Regulations, the Competition Rules as well as the Anti-Doping Regulations of the USPE shall apply. They have to satisfy the provisions set out in Article 23 of the USPE Statutes.

UNION SPORTIVE DES POLICES D'EUROPE

The participation in USPE Championships is restricted to athletes, who

- 1. meet the starting requirements of their international union,
- 2. belong to a national sports organisation that is a member of the USPE,
- 3. actually is a member of police organisation/force at the time of the championship or
- 4. are police students at a public police academy,
- 5. have reached the age of 18 at the time of the Championships or the Preliminary Rounds,
- 6. have signed the Anti-Doping Declaration and
- 7. submit the USPE Declaration of Participation signed by the respective President/Secretary General to the competent member of the Technical Commission.

The police are a set of all bodies and institutions in charge of maintenance of public law and order (administrative police and crime investigation departments).

Military police, members of the military, members of the fire brigades and civil servants that do not belong to the police are excluded from the European Police Championships and the Preliminary Rounds.

Competitors suspended from sports contests by the USPE or by the respective sports association due to having violated the relevant doping regulations are not eligible to enter.

#### 16. <u>Accreditation/Verification of eligibility to enter</u>

For verification of a person's eligibility, the police ID and passport or national ID-card (including a photo) must be presented to the delegate of the USPE. In case of a document deficiency, the permission to start may be refused.

According to the USPE Statutes, all participating countries must present the USPE Declaration of Participation for each athlete who will participate, signed by the respective President or Secretary General.

# Without the Declaration the participation in the USPE EPC Volleyball Women 2024 is not possible!

The competent member of the USPE Technical Commission, Mr. Dirk Weninger, will supervise the verification during the accreditation.

# To ensure an effortless procedure, the teams must complete the Declaration of Participation Form prior to accreditation.



# 17. <u>Anti-Doping</u>

Doping tests (urine and/or blood) will be conducted during the USPE EPC Volleyball Women with the current WADA list of prohibited substances being applicable (<u>www.wada-ama.org</u>).

According to the USPE Statutes, all participating athletes must present the self-signed USPE Anti-Doping Declaration.

Without this Declaration the participation in the USPE EPC Volleyball Women 2024 is not possible!

Each athlete can apply for TUE, i.e. permission to use, for therapeutic purposes, substances or methods contained in the list of prohibited substances or methods where use would otherwise be prohibited.

#### 18. Financial provisions

#### 18.1 <u>Travelling expenses</u>

Each member union will pay for its own travelling expenses.

#### 18.2 Board and lodging

The respective invoices have to be paid one month before arrival. Each participanting member union and guest are obliged to indicate a billing address (e-mail) to the organiser of this USPE EPC.

Each member union has to pay for board and lodging as follows:

#### <u>Delegate</u>

The organiser will pay for the expenses incurred by the delegate (Article R 11 of the USPE Rules and Regulations) of the participating member union.

#### <u>Team</u>

For every other participant (athlete/attendant)  $60,00 \in \text{per}$  person / per night must be paid to the organiser (Article R 14/3 of the Rules and Regulations).

#### <u>Guests</u>

Guests of this EPC must cover the actual costs of the overnight stay. The Intercity Hotel does not differentiate between single and double rooms when it comes to prices. Furthermore, the hotel rooms depend on the daily price.

As of  $2^{nd}$  May 2024, an overnight stay per day with full board including the final event would be 200,00  $\in$ .

The hotel will send the respective invoices for the guests.

#### 18.3 <u>Registration fee</u>

Prior to a championship, each participating country has to pay a registration fee in the amount of  $500,00 \in$  to the USPE before the opening of the championship. The USPE General Treasurer will send the respective invoices in time.

#### 20. <u>Restriction of personality rights</u>

The corresponding agreement (art. 6, par. 1 lit, and art. 7 European General Data Protection Regulation (GDPR)) of all participants (athletes, delegates, attendants) allowing the use of personal data during the competition, during the preparation for the competition, as well as after the competition and follow-up documentation of the competition in pictures and video sequences as PR procedures, for example by the USPE, has been obtained by the participating member country and is at hand in the original.
